

Truncated Case for Change

MSM Manufacturing Training Package Release 6.0

The following overview and attached Letters of Support are submitted for AISC consideration.

The Case for Change

IBSA Manufacturing is submitting this Case for Change on behalf of the Process Manufacturing, Recreational Vehicle and Laboratory Industry Reference Committee (PMRVL IRC) for the development of one new unit for the recreational vehicles industry. This unit will be housed in the MSM Manufacturing Training Package.

This Case for Change has been developed as a result of unit <u>AURVTT3016 Fabricate frame structures</u> being deleted from the <u>AUR Automotive Retail</u>, <u>Service and Repair Training Package</u>.

The proposed new unit is critical for the construction and repair of caravans and would be listed in MSM31115 Certificate III in Recreational Vehicle Manufacturing and MSM31015 Certificate III in Recreational Vehicle Service and Repair. There are currently several initiatives being implemented which are driving enrolments into these qualifications in the MSM Manufacturing Training Package, this is a key unit being used for training in the caravan industry. For example, the Caravan Trade & Industries Association of Victoria and have identified this unit as essential to the job role.

Industry Support for Change

The need to develop a new unit, to replace the deleted unit *AURVTT3016 Fabricate frame structures*, is essential for the recreational vehicles industry.

Industry consultation and engagement has been extensive and extremely supportive. As the representative of this industry on the PMRVL IRC, Stuart Lamont of the Caravan Industry Association of Australia has been heavily involved. During PMRVL IRC meetings, members have discussed and approved the development of a new unit in fabrication of frame structures that is specific to recreational vehicle manufacture.

As a result of these discussions, six national caravan industry associations have provided letters supporting the development of this new unit, which can be found in Attachment B below.

Impact of Change

The trade sector of the recreational vehicles industry generates \$985 million worth of wages and support over 20,800 jobs. Of these 5,450 individuals are employed within the manufacturing sector with a further 3,500 employees in the service and repair sector.

A new unit in frame structure fabrication is critical for the recreational vehicles sector. The new unit would enable learners to be skilled in a key area of recreational vehicle manufacture and would support the 397 caravan manufacturers in Australia (based on a survey conducted in June 2018) that produce approximately 23,000 units annually. In addition to the Australian-produced units, there are a further 10,000 units annually imported internationally which require servicing and repairing which the new unit would also cater for.



Although housed in the automotive training package, the deleted unit, *AURVTT3016 Fabricate frame structures* was originally designed to be used for the construction of frames used mostly by the caravan manufacture industry. The majority of manufacturers deal with light trailer manufacture and require the skills obtained from the *AURVTT3016 Fabricate frame structures unit*. In the construction of caravans, each van has up to 5 frames contained within it meaning there are approximately 100,000 frames manufactured annually in Australia. It is estimated in Victoria alone that the service and repair industry would repair approximately 200 frames a week. There are 400 service and repairers nationwide.

It is estimated it will take up to 6 months to complete the review work and implement the changes to the training package.

The submission of this Case for Change was agreed as the result of a properly constituted Process Manufacturing, Recreational Vehicle and Laboratory IRC decision.

AURVTT3016 Fabricate frame structures

As per our previous discussions we note that this training module for many businesses within the caravanning and camping industry has been deleted from AUR Automotive Retail, Service and Repair Training Package by the SSO.

We are writing to you to reinstate this unit as part of the elective banks of MSM31115 Certificate III in Recreational Vehicle Manufacturing and MSM31015 Certificate III in Recreational Vehicle Service and Repair.

We understand that the Department has requested further information along with support from our state and territory caravanning colleagues.

The unit in question - AURVTT3016 Fabricate frame structures was designed to be used for the construction of frames in our industry. All our walls frames, roof frames are constructed in manufacturing plants and then repaired in service and repair companies around the country.

This has legacy issues with industry qualifications sitting both in AUR and MSM packages in the old training environment. While some of our industry businesses mirror automotive packages, the majority of manufacturing and service businesses deal with light trailers (90% of manufactured product), and are requiring of the skills contained within this training module. The deletion only came to light as part of a Pilot training manufacturing program being run by Caravan Industry Victoria, as part of our collective efforts to establish a training culture within the industry, where all processes were mapped against the qualification.

In Australia there are 397 manufacturers in Australia (based on a survey conducted in June 2018) producing approximately 23,000 units annually. In addition there are a further 10,000 units annually being imported from around the world which require servicing and repairing. 159 of these businesses manufacture from Victoria alone. There are also over 400 service and repairers nationwide.

Each van has up to 5 frames contained within it meaning there are approximately 100,000 frames manufactured annually in Australia. It is estimated in Victoria alone that the service and repair industry would repair approximately 200 frames a week.



Caravan Industry Association of Australia is the peak national body for the Australian caravanning and camping industry. It works closely and collaboratively with each of the state caravanning associations with regard to matters impacting on industry businesses within the sector, including training.

The trade sector of our industry generates \$985 million worth of wages and supports over 20,800 jobs. Of these 5,450 individuals are employed within the manufacturing sector with a further 3,500 employees in the service and repair sector.

We attach following letters of support of the above position from our state association colleagues, who are charged with the overseeing of the delivery of the training qualifications. Caravan Industry Importance of AURVTT3016 Fabricate frame structures

We are writing to you to reinstate this unit as part of the elective banks of MSM31115 Certificate III in Recreational Vehicle Manufacturing and MSM31015 Certificate III in Recreational Vehicle Service and Repair.

The unit in question - AURVTT3016 Fabricate frame structures was designed to be used for the construction of frames in our industry. All our walls frames, roof frames are constructed in manufacturing plants and then repaired in service and repair companies around the country.

This has legacy issues with industry qualifications sitting both in AUR and MSM packages in the old training environment. While some of our industry businesses mirror automotive packages, the majority of manufacturing and service businesses deal with light trailers (90% of manufactured product), and are requiring of the skills contained within this training module. The deletion only came to light as part of a Pilot training manufacturing program being run by us, the Caravan Industry Victoria, as part of our collective efforts to establish a training culture within the industry, where all processes were mapped against the qualification.

The trade sector for the Caravan Industry in Victoria represents \$2.1 billion caravan industry economic contribution to Victoria up from \$1.4 billion in 2011, 6,587 total jobs in RV manufacturing, retail, repair and servicing up from 5,150 in 2011, \$680 million annual payroll and value-add across caravan industry up from \$453 million in 2011 and 90% of the Caravans and RVs produced in Australia. Our Association, Caravan Trades & Industries Association of Victoria (T/A Caravan Industry Victoria), is the peak body in Victoria for trade industry in Victoria and represents over 220 members.

We have developed a training division in 2015 known as the National Caravan Industry Training College which aims to provide the caravan industry with a career pathway including business and career opportunities with the right industry training programs. And it will significantly assist the way the industry does business while contributing to improving the level of professionalism and standards of the caravan industry over time.

In the development of our industry qualifications (MSM RV Packages) in 2013 it was identified that fabricate frame structures would play an important role in our industry as AURVTT3016 Fabricate frame structures was designed to be used for the construction of frames in our industry. All our walls frames, roof frames are constructed in the manufacturing plants and then repaired in service and repair companies.



As an example, in Victoria we have approximately 110 manufacturers that produce 90% of all RV's (23000) and each van will have 5 frames therefore approximately 103,500 frames are produced each year. In the service and repair industry they would repair approximately 200 frames a week.

The importance of this unit is extremely pressing as we currently have a \$2.1 million-dollar government grand with the Victorian Government as a part of the Workforce Training Innovation Fund with our project — Caravan Manufacturing Excellence. Where we are creating an Australian first training program for the manufacturing sector.

Our Association is member of Caravan Industry Association of Australia and we work together on a range of industry matters, including training and development. We agree that the unit of competency AURVTT3016 Fabricate frame structures should be reinstated within the MSM packages relating to Recreational Vehicles and Recreational Vehicles Service and Repair.

We ask that the Department consider this reinstatement as a matter of priority as the skills contained within this unit are widely used across the RV industry.
